

GEN 4. CHARGES FOR AERODROMES/HELIPORTS AND AIR NAVIGATION SERVICES

GEN 4.1 AERODROME/HELIPORT CHARGES

4.1.1. Previous

Charges for Airport Services:

Decree Nr 376/002 dated September 16th, 2002 numeral 4.12 and Annex F (Table of Prices) with the amendments introduced by Decree 317/003 dated August 13th, 2003

Decree Nr 420/003 dated October 24th, 2003 under the provisions of Decree 99/004 dated March 23rd, 2004 that perceived DINACIA

For Ground Handling Services to aircrafts the fare regime is free according to Decree Nr 280/002 dated July 22nd, 2002

Article 1. The charges and taxes for airport services must be paid by users in the currency, exchange rate, period of time and form that in each case is established in the present Decree.

Article 2. The airports and aerodromes are classified for the purposes of the payment of airport services as follows:

- a) First category: "Santa Bernardina" (Durazno) Alternate Intl Airport,
- b) Second category: Salto, Rivera, Melo, Colonia, Paysandú, Artigas and Ángel S. Adami Intl Airport.
- c) Third category: Others.

Article 3. The charges and taxes of the different services will be applied from August 15th, 2003 according to the following Tables:

A) Currency and rate of exchange to which the payments will have to adhere:
In U.S. Dollars (U\$S).

B) Form of payment and payment deadline:

- 1) Foreign air service companies with representation in Uruguay will have to settle monthly their corresponding invoice in an account in the Banco de la Republica Oriental del Uruguay that DINACIA indicates within the calendar month following to the month when the debt was originated. Within the same time period they will have to collect the receipt at the DINACIA on delivery of deposit slip.
- 2) Other users: the pending total amount owed will be billed at their postal address which will have to be sent to DINACIA within the 45 calendar days following to the invoice date.

C) Exemptions:

- 1) OAS, UN, ICAO, and RED CROSS aircraft
- 2) State Aircraft in no commercial mission and in a reciprocity situation
- 3) Search and rescue aircraft

D) Dispensations:

- 1) Aircraft landing in National territory
- 2) Aircraft deprived of Uruguayan Nationality
- 3) Aircraft flying exclusively according to visual flight rules
- 4) Foreign private aircraft will have to pay 30% of the price

A) Currency and rate of exchange at which payments will have to adjust
In U.S. Dollars (American Dollars – U\$S)

B) Form of payment and deadline

- 1) National airline companies and foreign airline companies with representation in Uruguay will be charged monthly their amount owed which will have to be deposited in an account of the Banco Republica that DINACIA indicates within the following calendar month to when the debt was originated.
- 2) Other users will have to make the payment in American Dollars or the equivalent figure in Uruguayan Pesos at the rate of exchange given by the Banco Central del Uruguay (Central Bank of Uruguay) for the American Dollar on the last day of the month previous to the date when the debt was originated, previous to take-off, the payment will have to be made at DINACIA to the staff in charge of revenue collection.

C) Exemptions:

- 1) Aircraft whose operators or charterers be the OAS, UN, ICAO or RED CROSS.
- 2) State aircraft in no commercial mission in reciprocity situation.
- 3) Aircraft forced to land in Uruguayan territory by Uruguayan authorities.
- 4) Aircraft having departed from a National airport which interrupt their flight to their destination and return to the departing airport.
- 5) Aircraft making test or instruction flights.

D) Dispensations:

- The aircraft of General Aviation and National airlines with aircraft registered in Uruguay in National flights will be
- exempted from the application of this table until December 31st, 2003.

TABLE 3: FARE FOR PARKING.

1) Foreign aircraft:

The fare will be applied to Commercial and General Aviation aircraft after three (3) days and one (1) hour of parking at the airport, charging:

- a) On operative apron 5% of the daylight landing price which corresponds to the aircraft, per hour or fraction.
- b) Out of operative apron (at those airports which have this facility) 2,5% of the daylight landing price which corresponds to the aircraft per hour or fraction.
- c) Foreign aircraft under repair in authorized mechanic repair hangars at the airports will not pay for parking while under repair, but must be subject to regulations that the collecting department may establish.

2) National aircraft:

- A) Aircraft registered in Uruguay will pay the parking fare only at Carrasco International Airport.
- B) Currency and rate of exchange at which the payments should be adjusted:
In U.S. Dollars (American Dollars – U\$S).
- C) Form of payment and deadline:
 - 1) National airline companies and foreign airline companies with representation in Uruguay will be charged monthly their amount owed which will have to be deposited in an account of the Banco Republica that DINACIA indicates within the following calendar month to when the debt was originated.
 - 2) Other users will have to make the payment in American Dollars or the equivalent figure in Uruguayan pesos at the rate of exchange given by the Banco Central Del Uruguay (Central Bank of Uruguay) for the American Dollar on the last day of the month previous to the date when the debt was originated, previous to take off, the payment will have to be made at DINACIA to the staff in charge of revenue collection.

D) Exemptions:

- 1) Aircraft whose operator or charterer be the OAS, UN, ICAO, RED CROSS.
- 2) State aircraft in no commercial mission in reciprocity situation.
- 3) Aircraft forced to land in Uruguayan territory by Uruguayan authorities.
- 4) Aircraft having departed from a National airport and interrupt their flight to their destination and return to the departing airport.
- 5) Out of the operative apron, the aircraft which have a base at the airport (clearly authorized by the Direccion General de Aviacion Civil)

The Organism will invoice monthly the amount owed, and should pay the same by deposit in Banco de la Republica Oriental del Uruguay, within 10 (ten) days of the following calendar month. Subsequently, the correspondent receipt must be obtained in DINACIA upon delivery of the deposit proof.

Form of payment and deadline:

The Organism will invoice monthly the amount owed, and should pay the same by deposit in Banco de la Republica Oriental del Uruguay, within 10 (ten) days of the following calendar month. Subsequently, the correspondent receipt must be obtained in the accountant's office of DINACIA.

Form of payment and deadline:

- It must be paid prior to takeoff to DINACIA official in charge of collecting, prior to takeoff of the aircraft.

- 2) For cases where there is current account enabled, you will be billed monthly and could pay in the Accounting office of DINACIA within 10 (ten) days following the month expired, or in the account of Banco de la República that this indicates presenting in the same period the deposit ticket that will be exchanged for a receipt.

Prior to obtaining or renewing the Certificate of Airworthiness for the aircraft, shall be paid at the División Financiero Contable (Division of Financial Accounting) of DINACIA.

Exemptions:

State-owned aircraft and Air clubs and aircraft manufacturing over 50 years

Dispensations:

The application of this Table shall be suspended during 2003

Form of payment and deadline:

- 1) The airworthiness companies are retention agents from payment of this price that will be charged together with the amount of the ticket price at the time of issue, in the same currency.
- 2) The companies shall deposit the amounts collected on account of Banco de la Republica Oriental del Uruguay that DINACIA instructed, within one month following that in which the ticket was issued
- 3) In the same period it shall submit to DINACIA the affidavit with all shipments made and payroll exempt from payment under this Decree, attach the original deposit made

Out of normal business hours at the airport, aircraft operators must pay UR 1,45 ($\$1,45 \times vUR$) per hour or fraction enablement. (This single amount will be charged by the concepts of takeoff, landing and flight protection).

A) Form of payment and deadline:

- 1) It must be paid to DINACIA official in charge of collecting, after landing and prior to takeoff of the aircraft.
- 2) For cases where there is current account enabled, you will be billed monthly and could pay in the Accounting office of the DINACIA within 10 (ten) days following the month expired, or in the account of Banco de la República that this indicates presenting in the same period the deposit ticket that will be exchanged for a receipt

Article 4th: The DINACIA will deposit monthly in the Banco Republica account that the Dirección General de Meteorología (National Meteorological office) indicates, the 2% of the disposable monthly turnover for flight protection price conception for the use of the facilities and air navigation services (Table 1) once received effectively.

Article 5th: The DINACIA is empowered to carry out the necessary controls as well as inspections and impose sanctions in accordance with the title XVI of the Aeronautical Code (Decree-Law 14.305 dated November 29th, 1974)

Article 6th: Hereby established the following adjustment procedure in the collection of fares:
U.S. currency payments will be adjusted as follows:
Up to 0.50 cents (inclusive) to the lower unit and the ones that exceed, to the upper unit.
Payments on Unidades Reajustables (adjustable units), which amounts in local currency finished at 5 or less will be adjusted to 0 of the decade before and the amounts ending in 6 or greater shall be adjusted to 0 in the subsequent decade.

Article 7th: Failure to timely payment of prices for services established by this Decree, shall result in a charge similar to that set by Article 94 of Decree-Law 14,306 dated November 29th, 1974, as amended by Article 1st Law 16,869 of September 25th, 1997, namely: "The penalty is 5% (five percent) of the price not paid on time, when the same is paid within 5 (five) business days following its expiration. The penalty is 20% (twenty percent) when paid later. In addition to the fine, failure to pay will result in a similar monthly fee set by the Poder Ejecutivo (Executive Power) for non-payment of tax obligations."

Article 8th: Repealed Decree 160/001 of May 7th, 2001 and 407/001 of October 16th, 2001, in all that is contrary to this Decree

AIRPORT SERVICE FARES AT “Gral. Cesáreo L. Berisso” CARRASCO INTERNATIONAL AIRPORT

The following summarizes current fares and conditions for airport services in charge of the operator Puerta del Sur S.A., at the "Gral Cesareo L. Berisso Carrasco International Airport" according to the provisions of Annex F of the Comprehensive Management Regime complementary of Decree 317/03.

- c) Aircraft forced to land in Uruguayan territory by Uruguayan authorities.
- d) Aircraft having departed from a National airport which interrupt their flight to their destination and return to the departing airport.
- e) Aircraft making test or instruction flights.
- f) Public aircraft under Article 69 of the Aeronautics Code of Uruguay.

TABLE 2: FARE FOR PARKING

The price applies to domestic and foreign aircraft, commercial and general aviation after 3 (three) and 1 (one) hours respectively to stay in the airport, claiming on this account:

- a) In operating platform 5% (five percent) of the price corresponding to diurnal landing of the aircraft, per hour or part thereof.
- b) Other operating platform 2.5% (two and half percent) of the price corresponding to diurnal landing of the aircraft per hour or part thereof.
- c) Foreign aircraft on mechanical repair at authorized workshop, shall not pay the parking price for the duration of the repair, and should be adjusted to the provisions established by the Licensee in this regard.

2.1. Form of payment and deadline:

- a) The domestic air services companies and foreign representation in the country, they are billed monthly the amounts which should be deposited in the bank account that Puerta del Sur SA indicate within 30 days of the invoice date.
- b) Other users: cash, prior to takeoff.
- c) Payments will be made in dollars of the United States.

2.2. Exemptions:

- a) Aircraft whose operators or charterers are the OAS, UN, ICAO or RED CROSS.
- b) State aircraft in no commercial mission in reciprocity situation.
- c) Aircraft forced to land in Uruguayan territory by Uruguayan authorities.
- d) Aircraft having departed from a National airport which interrupt their flight to their destination and return to the departing airport.
- e) Outside the operating platform, aircraft based at the airport (properly authorized by the Dirección Nacional de Aviación Civil e Infraestructura Aeronáutica).
- f) Public aircraft under Article 69 of the Aeronautics Code of Uruguay.
